#### **OSHA Stakeholder Meeting**

OSHA invites interested parties to participate in an informal stakeholder meeting concerning updates to OSHA'S Process Safety Management (PSM) standard, at which OSHA will provide a brief overview of its work on the project to date. Additionally, OSHA invites participants to provide public comments related to potential changes to the standard that OSHA is considering.

**DATES:** The stakeholder meeting will be held on October 12<sup>th</sup>, 2022. Registration to participate in or observe the stakeholder meeting will be open until all spots are full. Written comments must be submitted by October 28<sup>th</sup>, 2022.
