The U.S. Department of Labor's Occupational Safety and Health Administration will hold an online meeting of the National Advisory Committee on Occupational Safety and Health on January 10, 2023, from 2 to 4 p.m. ET. Open to the public, the meeting will include updates about the committee's membership and recent OSHA developments, a report from the Heat Work Group, and follow-up discussion on the agency's Whistleblower Protection Program.
