## **Government Affairs Update**

#### ANSI/ASSP A10.2-2025, Safety, Health and Environmental

Training for Construction and Demolition Operations establishes best training practices to help organizations nationwide eliminate hazards and risks that cause injuries, illnesses, and fatalities.

The types of applicable training on construction and demolition sites include new hire, site safety, regulatory, pre-job, supervisor leadership, and retraining. Training evaluations, documentation, and record-keeping are also key components of a workplace safety and health program.

### OSHA Updates Recordkeeping Directive

1. Updates guidance to help OSHA compliance officers assess workplace injury and illness records.

2. It incorporates advancements in workplace safety standards and reporting technology.

3. It reflects nearly two decades of safety and health regulations developments.

## Road to Zero: A Plan to Eliminate Roadway Deaths



The U.S. Department of Labor's Occupational Safety and Health Administration (OSHA), the National Safety Council, and the Road to Zero Coalition have partnered to reduce fatal workplace motor vehicle incidents, which are the leading cause of workplace deaths in the U.S. In 2023, nearly 37% of fatal work injuries were related to transportation. The initiative aims to promote a culture of safety and preventative practices to protect workers on the road, encouraging employers to integrate safe driving into their safety management systems. OSHA's Motor Vehicle Safety webpage offers resources for employers to create policies on vehicle maintenance, seat belt use, and addressing distracted or impaired driving. This collaboration strives to improve road safety for both workers and the public.

RTZ promotes the Safe System Approach to preventing roadway deaths, which recognizes that all of the following factors are necessary to save lives: Safer People, Safer Vehicles, Safer Speeds, Safer Roads, and Post-Crash Care.

In addition, RTZ's work is guided by the following Safe System principles:

- Death and serious injuries are unacceptable
- Humans make mistakes
- Humans are vulnerable
- Responsibility is shared
- Safety is proactive
- Redundancy is crucial

### **ASSP Offers Key Insights on :**

### OSHA Proposed Heat Injury and Illness Prevention Standard

#### **Opportunities and Challenges**

- 1. Potential to address heat-related hazards.
- 2. Implementation challenges.

3. Alignment with voluntary standards. ASSP members appreciated OSHA's recognition of ANSI/ASSP A10.50-2024, which reflects the value of leveraging voluntary national consensus standards in regulatory efforts.

#### **Key Concerns and Recommendations**

- Heat safety training based on ANSI/ASSP A10.50 be recognized as compliant supplemental training.
- Heat-related factors. This section should address critical variables such as physical condition, weather factors, clothing, activity level, and medication effects that can impact heat-related risks.
- Recordkeeping and reporting. OSHA needs to clarify recordkeeping requirements before issuing a final rule.
- Heat triggers and metrics. The Wet Bulb Globe Temperature (WBGT) index used in A10.50 is more comprehensive than the heat index metric in OSHA's proposal.
- Heat safety coordinator role. ASSP recommends using OSHA's existing definitions of "competent person" and "qualified person" instead of creating new roles that could cause duplication and confusion.
- Paid rest breaks. Cautioned OSHA against wading into wage-related issues.

#### Heat Injury and Illness Prevention Programs

ASSP also recommends that the proposed rule contain more performance-based elements similar to those in OSHA's Process Safety Management standard. ANSI/ASSP A10.50 is a much more comprehensive and impactful standard than the OSHA proposed rule and should be explicitly referenced as a model for program creation.

- 1. Use of metrics. A10.50 relies on WBGT, which accounts for factors like sunlight, air movement, and local radiant heat, providing a more accurate measure of heat risk.
- 2. Stop work authority and competent persons. A10.50 requires stop work authority and explicitly defines the role of a qualified person.
