NIOSH Reinstatement: A critical step forward for worker safety

The Department of Health and Human Services (HHS) has reinstated several hundred NIOSH employees, particularly those involved in vital programs such as black lung disease screening and respirator testing. These reinstatements follow a preliminary injunction that mandates the immediate restoration of the NIOSH staff and the continuation of health surveillance programs under the Mine Safety and Health Act.

The National Utility Contractors Association and OSHA promote Trench Safety Month every June to focus on trench and excavation safety issues, with a Safety

• Stand Down taking place June 16-20.



OSHA updates inspection inspection program focusing on workplace with highest injury & Illness rates.

- OSHA announced it has updated the inspection program that directs the agency enforcement resources to establishments with the highest rates of injuries and illnesses Based on injury and illness data submitted.
- OSHA's primary planned inspection program for non-construction establishments with 20 or more employees. Using OSHA Form
- 300A data from calendar years 2021-2023, establishments may be selected for inspection based on:
 - High injury and illness rates from 2023 data. Upwardly trending injury and illness rates based on 2021-2023 data at or above
 - twice the 2022 private sector average.
 - Injury and illness rates are markedly below industry averages.
 - Failure to submit an OSHA Form 300A in 2023.

PHMSA ADVISORY BULLETIN PROMOTES IMPLEMENTATION OF PIPELINE SAFETY MANAGEMENT SYSTEM

The Pipeline and Hazardous Materials Safety Administration (PHMSA) has issued an advisory bulletin on pipeline safety management systems (PSMSs), encouraging all regulated pipeline owners and operators to adopt new safety management systems voluntarily. PSMSs offer an organization-wide framework for evaluating, managing, and responding to the safety risks associated with various complex pipeline operational processes. The National Transportation Safety Board has encouraged the implementation of PSMS and first recommended that the American Petroleum Institute facilitate the development of a PSMS following the July 2010 release of more than 20,000 barrels of crude oil into the Kalamazoo River near Marshall, MI. Pipeline owners and operators have implemented PSMSs

on approximately 86% of the 2.3-million-mile U.S. gas distribution pipeline network. Despite this, many individual operators—primarily smaller entities servicing fewer than 25,000 customers—have not yet begun implementing PSMS based on this or similar programs, according to PHMSA.

"Safety management systems bring about a much-needed evolution of internal pipeline safety management structures, policies, and procedures that will ultimately lead us to achieve our goal of zero incidents," says PHMSA's Ben Kochman. "We encourage all regulated pipeline owners and operators to fully embrace the continuous improvement and enhanced safety benefits that come with implementing a PSMS."
